
Literature Review

Instructions

The Literature Review provides a comprehensive analysis and synthesis of the literature to help you investigate your research topic and find gaps in the literature. It's driven by your research question(s) and target population. Below is the structure for your Literature Review. Word counts listed are approximate in the figure below are suggested; however, they will vary depending upon the literature that you are able to find. In general, you are working towards a 2,500 - 3,000 word literature review.

Figure 1: Literature Review Structure



Important things to consider when writing your Literature Review:

- Your themes must be related to your research topic. Ensure that you stay on topic and that the supporting evidence comes from quality academic sources and is relevant to the context of your study and target population.
- Include academic, peer-reviewed publications.
- Use a combination of theoretical and empirical research to support your arguments.
- Include recent articles (within the past 5 years).
- Demonstrate familiarity with the evolution of the concepts (i.e., foundational scholars, recent literature, trends, gaps).
- Ensure that you follow APA 7th edition guidelines.
- 2,500 3,000 words
- 20-25 scholarly sources
